Can a drilling company sue a man who was injured on an oil rig?

June 25,2020 -- A Texas appellate court has ruled that a drilling company in Louisiana will not have to face a lawsuit from a man who was injured on an oil rig, according to Law360. The \$1 million injury lawsuit was filed against Baywater Drilling LLC by Benjamin R., a man who suffered severe neck and back injuries on the job.
